2 RELATING TO CRIMES; PROVIDING A STATEMENT OF LEGISLATIVE INTENT; AMENDING
3 TITLE 18, IDAHO CODE, BY THE ADDITION OF A NEW CHAPTER 79, TITLE 18,
4 IDAHO CODE, TO PROVIDE A STATEMENT OF PURPOSE; TO PROVIDE THAT MALI-
5 CIOUS HARASSMENT IS A CRIME; TO PROVIDE CRIMINAL PENALTIES; AND TO PRO-
6 VIDE SEVERABILITY.

7 Be It Enacted by the Legislature of the State of Idaho:

8 SECTION 1. It is not the intent of the legislature that this chapter
9 be construed or used to support ratification by the United States Senate of
10 the United Nations Convention on the Prevention and Punishment of the Crime
11 of Genocide of 1948.

12 SECTION 2. That Title 18, Idaho Code, be, and the same is hereby
13 amended by the addition thereto of a NEW CHAPTER, to be known and desig-
14 nated as Chapter 79, Title 18, Idaho Code, and to read as follows:

16 MALICIOUS HARASSMENT

17 18-7901. PURPOSE. The legislature finds and declares that it is the
18 right of every person regardless of race, color, ancestry, religion,

With any of the history lines, you would start by looking at Session Laws for the year you are interested in and the corresponding chapter number from the history line. We have Session Laws going back to 1945 on our website ([Idaho Session Laws – Idaho State Legislature](#)), but only have materials on bills and any committee minutes for legislation from 1998 to present. Any legislation older than that would need to be researched using materials from the Legislative Library.
