In May 2017, speaking at the Opening Ceremony of The Belt and Road Forum for International Cooperation, President Xi Jinping of China brought cutting-edge technologies and the ongoing global Fourth Industrial Revolution to the BRI. "We should pursue innovation-driven development and intensify cooperation in frontier areas such as digital economy, artificial intelligence, nanotechnology and quantum computing, and advance the development of big data, cloud computing and smart cities so as to turn them into a digital silk road of the 21st century," he said.
