Officer Safety/Intel

According to the FBI, First Amendment Auditors are more aggressively targeting law enforcement officers. ***As of mid-June 2019, individuals associated with First Amendment Auditors have increased their tactics to obstruct law enforcement operations by shining high-powered flashlights in the face and eyes of police officers during nighttime traffic stops and other call for services.*** Individuals associated with First Amendment Auditors have used police scanners to locate police activity in the area and record law enforcement operations. ***Individuals have also increased their rhetoric advocating for the random killing of law enforcement officers and called for others to do the same.***

Individuals associated with First Amendment Auditors advocate for citizen journalism testing constitutional rights, specifically First Amendment Protected speech. Associated individuals are known to confront law enforcement in an effort to provoke a violation of their constitutional right/s. First Amendment Audit locations generally include law enforcement facilities, court houses, Department of Defense facilities, and any event that has police presence.

As an example of a local associate of the group, Casey Whalen (12/9/77) makes YouTube videos to voice complaints about local law enforcement and spread First Amendment Auditor rhetoric. Daily Flyer summary 9/4/19: On 8/29/19, Whalen was contacted at the Public Safety Building where he was filming people and asking to arrest a judge. Whalen espoused some questionable constitutional theories, acted paranoid and confrontational, and appeared to have a homemade "press badge." Whalen has been contacted at the Federal Courthouse in Coeur d'Alene and the CDA Police Department and seemed intent to start a confrontation with security over the video recording policy (per one of the videos Whalen made). **Information only- Whalen is not wanted.**

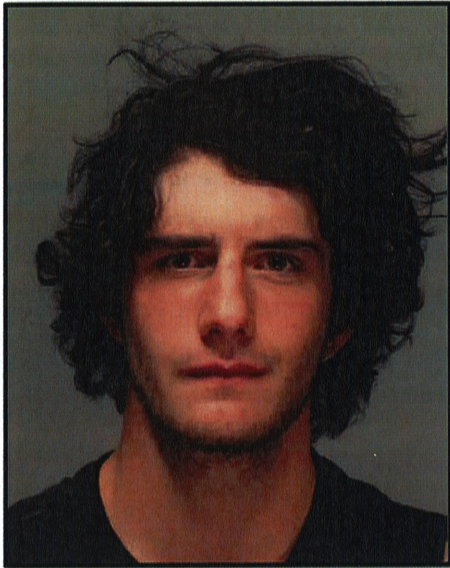

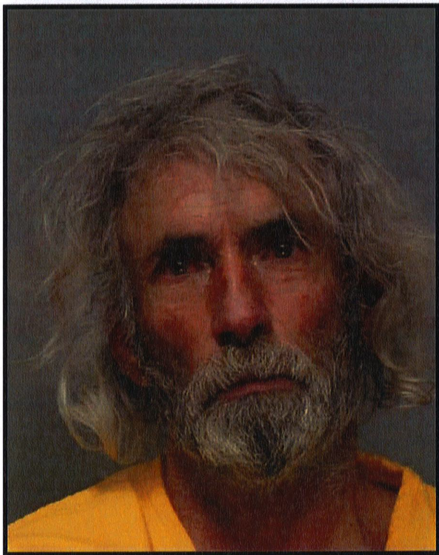

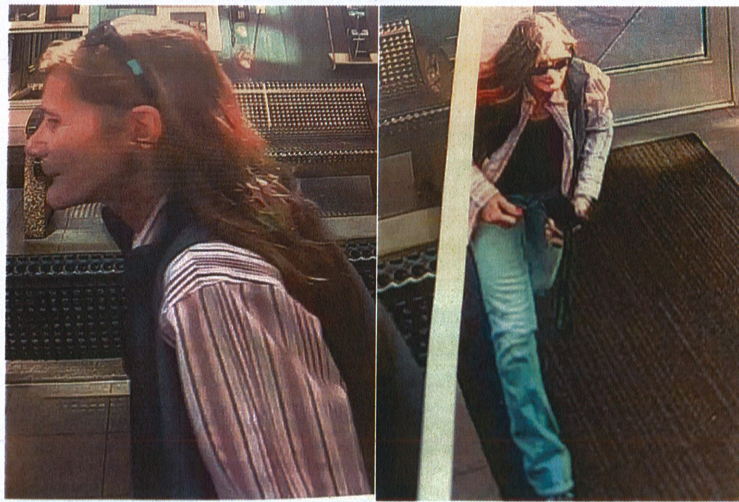
