

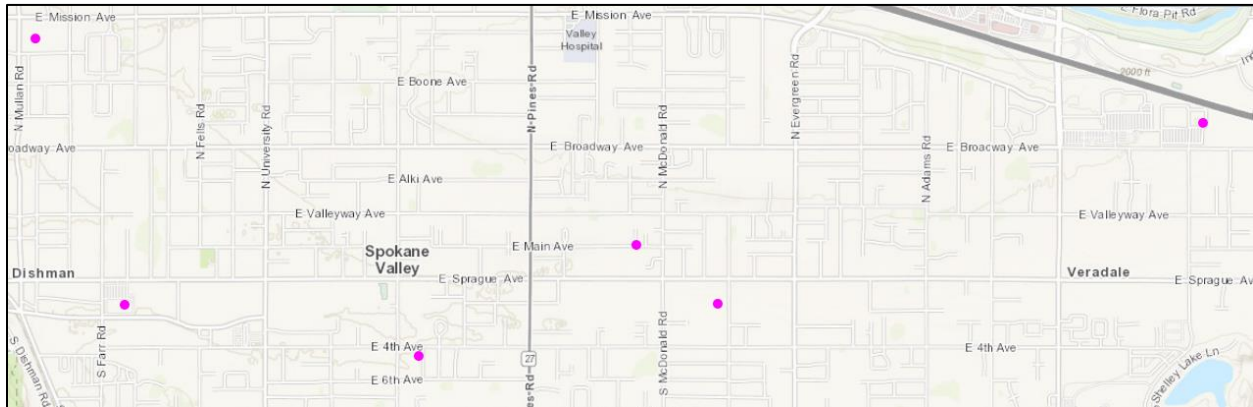

Officer Safety / Awareness

On 3/16/18, Casey Whalen (12/9/77) was contacted in the front lot of the Coeur d'Alene Police Department on N Schreiber Way. He was filming the department, including all the walls and the drive-in gate to the back parking lot. While still filming, Whalen went to the records department with copies of the Idaho State Constitution, the Declaration of Independence, and the U.S. Constitution. When confronted as to why he was filming, he refused to answer and stated it was his constitutional right. Whalen continued to film the interaction and refused to leave the property. He also refused to identify himself, but was recognized by officers. Whalen left the premises on foot. There is no PC at this time, for information only.

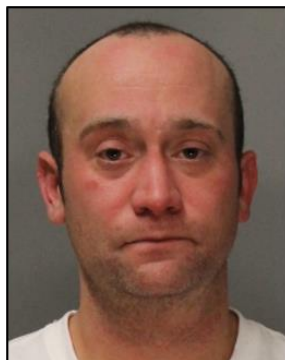

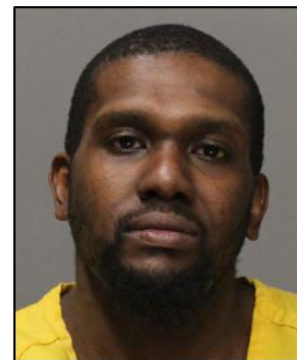
