Leadership for a Changing World Award

In 2003, the Montana Human Rights Network was one of the finalists for the Ford Foundation's *Leadership for a Changing World*. The recognition included a grant for their work. Notice on the bottom left – Native American Leaders Transcend Borders.

The *Leadership for a Changing World* is a program of the **Ford Foundation** (founded 1936-reorganized and reconstituted in 1948), the <u>Institute for Sustainable Communities</u> and the Robert F. Wagner School of Public Service, New York University.

[Robert Strange McNamara] - President of the Ford Motor Company, Secretary of Defense, President of the World Bank. [The Bank that McNamara left in 1981 was completely transformed from the institution he had entered thirteen years earlier. It was a much larger organization, and much more complex. Its membership had continued to expand, and with the People's Republic of China assuming full participation, it was well on its way to becoming a universal organization]. Systems thinking and Management Economics. Lester Pearson, Commission on International Development]

The Institute for Sustainable Communities was co-founded by Madeleine Kunin and Jonathan Lash both of whom were on the Clinton-Gore President's Council on Sustainable Development (PCSD). Notice that one of the <u>task forces for the PCSD</u> was Sustainable Communities.

Originally, The Advocacy Institute ran the Leadership program 2000-2006

Each year, *Leadership for a Changing World* recognizes 17-20 leaders and leadership groups not broadly known beyond their immediate community or field. Nominated community leaders may work in fields that include: **economic development**; **community development**; **environment and environmental justice**; human rights; citizen participation and government accountability; human development; sexual and reproductive health; education reform; youth development; religion and social change; arts and social action; and access to media, including new technologies.

The MHRN nomination for the award was made in December of 2003. The award was received 2004.

This is an excerpt from the article describing the MHRN and the work they do that was the reason for the award (links added).

MHRN's mission is to promote the democratic values of pluralism, equality, and justice; to challenge bigotry and intolerance; and to organize communities to speak out. When skinheads harassed Jewish families, for example, MHRN worked with local activists to organize a "Not In Our Town" campaign, which subsequently became a national model of community response to bigotry and racial violence. The Network also issued a seminal report on the militia movement that was cited by media nationwide following the 1995 bombing of the Oklahoma City federal building.

As the militia movement spread, the American Jewish Committee, an international human rights organization, commissioned MHRN to write a report: What to Do when the Militia Comes to Town, a community organizing manual disseminated nationwide. From confronting extremist militia organizations to advocating for gay rights and American Indian tribal sovereignty, Toole and Kaufman have been unflinching advocates for social justice. They also have established the Policy Institute, a think tank that addresses what Toole and Kaufman describe as the failings of the progressive movement, and how it can become more effective.

1995 bombing of the Murrah Building in Oklahoma City

[Side Note: the 1995 bombing of the Murrah Building in Oklahoma City was the excuse Clinton gave for what ultimately has become the American STASI - police state systems of surveillance and control.
