NARRATIVE:

██████████ explained that he does not believe that ██████████ knows where he lives,

but is concerned that if [REDACTED] discovered his residence that he might follow through with the threat. [REDACTED] also explained that [REDACTED] is scared that [REDACTED] will show up at there residence and harm the family. [REDACTED] stated that [REDACTED], and they are talking about moving due to the threats presented by [REDACTED]

[REDACTED] did not wish to pursue charges for violation of Idaho Code 18-6710 Use of Telephone to Annoy, Terrify, Threaten, Intimidate, Harass or Offend. [REDACTED] was adamite that he wanted the messages to stop and for [REDACTED] to get help.

I asked [REDACTED] why he has not blocked [REDACTED] number. [REDACTED] stated that he did not want to block the number do to [REDACTED], and that if [REDACTED] sent him a text of an imminent threat he wanted to be able to alert authorities.

While checking [REDACTED] [REDACTED] [REDACTED] [REDACTED]

[REDACTED] a long time friend of [REDACTED] answered his phone and spoke to me. [REDACTED] stated that [REDACTED] [REDACTED] and that [REDACTED] did not follow it. [REDACTED] explained [REDACTED] [REDACTED] and he has not been involved with [REDACTED] since. [REDACTED] stated that [REDACTED] [REDACTED] [REDACTED] until he is arrested for a major crime. [REDACTED] stated that once [REDACTED] is arrested, he will "sit in a jail cell, untreated, and come out worse than when he went in." [REDACTED] also explained that he suspects [REDACTED] has not slept in 3 weeks, and as he refuse to sleep things will only get worse.

[REDACTED] explained he does not believe that [REDACTED] is a violent person, and would not hurt anyone. [REDACTED] stated that [REDACTED] [REDACTED], and he will target caring people or people who will respond to him, and attempt to get a rise out of them. [REDACTED] stated the only way to break the cycle is for [REDACTED] to be placed on a hold or for him to be arrested and given [REDACTED] [REDACTED]. [REDACTED] stated that after the [REDACTED], [REDACTED] will calm down, and "be normal." [REDACTED] was also concerned to hear that [REDACTED] had recently purchased a firearm. [REDACTED] does not believe that [REDACTED] would use it on a person, but also recognized he was [REDACTED]

[REDACTED] explained that [REDACTED] has a master's degree in Child Psychology and understands the circumstances around his behavior. [REDACTED] stated that if [REDACTED] is taken on a protective hold he knows exactly what to say to get released. [REDACTED] stated the [REDACTED] will attempt to get law enforcement on his side to fight the same "evil" he is trying to fight. [REDACTED] explained that [REDACTED] is normally cooperative with law enforcement until "he is cornered or done talking." [REDACTED] also stated that [REDACTED] feel secure and safe around larger men. [REDACTED] stated that [REDACTED] went to the University of [REDACTED] and was one of the people who ran the buffalo onto the football field. [REDACTED] stated "if the officer's are large football players," [REDACTED] will respond better.

[REDACTED] provided me multiple screen shots of the text messages sent from [REDACTED] I uploaded all messages to the KCSO server.

Due to [REDACTED] not wanting [REDACTED] charged for violation of Idaho Code 18-6710 Use of Telephone to Annoy, Terrify, Threaten, Intimidate, Harass or Offend. No chargers were filed at the time of this report. [REDACTED] was advised that he had a year and one day to file the charges if he so wished.

I spoke with [REDACTED] via phone on 5/1/2023, and warned him of the consequences if he continued to send unsolicited threatening text messages to [REDACTED]. [REDACTED] was informed that [REDACTED] did not wish to pursue charges at this time, but wished for him to seek help. [REDACTED] was understanding and said he became frustrated last night (4/30/2023) over politics and should not have sent the messages.

[REDACTED] appeared to be in good spirits throughout our conversation. [REDACTED] advised he is [REDACTED], [REDACTED]. [REDACTED] stated that he would speak with [REDACTED]. [REDACTED] explained he has no intention of harming anyone.

Considering the totality of this incident, [REDACTED] does not present an immediate threat to himself or others, and therefore; cannot be placed under protective custody for a mental health evaluation. [REDACTED] was urged to find a different release than sending threatening messages to people.

I had no further involvement with this case.

This incident was captured on my in-car dash camera as well as my body worn camera. For the complete details and circumstances of this case please refer to the videos. This report is a summary of the events to my best ability.
