

NARRATIVE:
On 4/30/2023 at approximately 1915 hours, I (Deputy R. Flory) responded by phone to a report of threatening behavior. Call notes indicated that was reporting that was reporting that was sending text messages about having a new gun and "can't wait to hunt him down."
I spoke with by phone who stated that he met approximately a year and a half ago while filming a documentary on mental health. stated that appeared normal, and "had a great story." explained that during the filming he noticed and it appeared that had the to the stated that after the filming was canceled continued to contact him by text message.
stated that started sending messages telling for the safety of his family, he need to change teams, and that all Trump supporters will die, and that he will give transphobic people the "death penalty." also stated that stated that sent him a screen shot of a firearm he purchased in September 2022
It should be noted that Coeur D'Alene Police Department contacted 3/6/2023 for a Welfare Check in regards to statements had posted online. In the report the officer refers to believing White Nationalist were after him, and that he felt exposed in his second story apartment. also openly stated that he possess a Kimber 1911 10 mm handgun.
explained that the text messages from have been consistent, and that he used to engage in conversation over the text messages in an attempt to "help" him. Stated that would usually apologize for messages sent, and appeared to recognized that the threatening messages were wrong. Stated that last couple months, messages have became personal, more aggressive, and that is showing less remorse. Explained that last month, he stopped responding to due to the nature of the text messages.
explained that has sent him "three finger scrolls" worth of messages since telling he did not want to speak with him anymore. By swiping on my phone, I estimate that has received more than 100 unprovoked messages in the last month. Stated that today, he received a messages from stating that he had been shooting his gun and cannot wait to hunt him down. Stated to a message about the fall of 2024 operation elimination will commence.
explained that he does not believe that knows where he lives,



I spoke with via phone on 5/1/2023, and warned him of the consequences if he continued to send unsolicited threatening text messages to was informed that did not wish to pursue charges at this time, but wished for him to seek help. was understanding and said he became frustrated last night (4/30/2023) over politics and should not have sent the messages.
appeared to be in good spirits throughout our conversation. advised he is
Considering the totality of this incident, does not present an immediate threat to himself or others, and therefore; cannot be placed under protective custody for a mental health evaluation. was urged to find a different release than sending threatening messages to people.
I had no further involvement with this case.
This incident was captured on my in-car dash camera as well as my body worn camera. For the complete details and circumstances of this case please refer to the videos. This report is a summary of the events to my best ability.
